# Specific prerequisites

Completed upper secondary education including documented proficiency in Swedish corresponding to Swedish B and English corresponding to English A. For students who received/will receive their final school grades after 31 december 2009, there is an additional

entry requirement for mathematics as follows: documented proficiency in mathematics corresponding to Mathematics A.

Specific requirements of mathematics, physics and chemistry (or natural science) corresponding to: Mathematics D, Physics A and Chemistry A. Physics A and Chemistry A can be replaced by Natural Science B.

## Language of instruction

The language of instruction is specified in the course offering information in the course catalogue.

## Intended learning outcomes

The students should after the course be able to:

- Explain the function, financing and management of the real estate market.
- Explain the content of the Land Code and the Real Property Formation Act.
- Explain the content of the Estate Agents Act and the different parts of the process of mediating property.
- Describe the requirements for and obligations of real estate agents and real estate developers.
- Make capital investment appraisals and reflect upon how these are connected to public investment appraisals.
- Find and use different sources of information for the written assignment.
- Write a well-structured and informative essay and orally present the results.

#### **Course contents**

The aim of the course is to give the student a basic understanding of how real estate agents and real estate developers work in order to meet the sellers, customers and authorities demands on impartiality during the process of mediating property. The course includes, inter alia, the question how the work to increase the value of real property is affected by the Estate Agents Act, the Real Property Formation Act and other central legislation. The course is intended to give an broad introduction to the subject area as an introduction to the program Property Development and Agency. Law, marketing, financing and ethics are central parts of the mediating process and thus of the course.
