- identify and analyse problems regarding management and ethics, with a special emphasis on real estate and financial firms.
- describe, analyse and problematize management theories
- · analyse and reflect on management within real estate and financial markets
- have a working knowledge of the normative management theories and models that are the basic analysis tools of the course
- apply the ethical problems and possible solutions that are included in the applied part of the course
- independently analyze texts from an ethical perspective
- independently analyze cases from management literature
- write text analyses from an ethical perspective independently using the etical theories and analytical tools provided in the course literature

- Management theory and different schools of theory focusing on change and value creation in management and organization
- Ethics and moral theory and practice in real estate and finance
- Practical applications management in real estate businesses and financial organizations
