# Language of instruction

The language of instruction is specified in the course offering information in the course catalogue.

### Intended learning outcomes

The overall objective with the course is that the student after finished course should know the system of law that regulates changes of land use by development and have basic knowledge about the rules regarding protection of nature and built environment.

#### After fulfilled course the student is able to:

Describe the authorities responsibilities in the decisions regarding land use and building

Describe the system of laws regulating and controlling land use

Describe the basics of the system of laws governing protection of natural and built environment

Applying this in cases of various types by:

- Identifying the legal rules and plans that affect a given situation
- Explain how these legal rules affect the situation
- Suggest possible solutions to problems with the support of the legal text

Make estimates of potential property refinement under the Act and current plans.

Present own solutions and critical compare and discuss own and others solutions on relevant problems to develop better conclusions.

#### For higher grades, the student should be able to:

Explain the relationship between the different laws

Explain the meaning of more difficult to interpret legal parts in these systems

Apply legislative provisions on more complex cases by

- Identify the rules that affect a given situation
- Explain how these rules affect the situation
- Suggest possible solutions to problems with the support of the legal text

### **Course contents**

The course is based on actual development projects. In these, we focus on the legal aspects of planning processes, permits and other decisions that may be necessary.

Lecutres, workshops and preparatory exercises highlighting these issues. The course also includes a project in which the knowledge shall be applied on a real case.

## Disposition

The course includes lectures, digital preparation tasks and exercises. The course ends with a compulsory assignment to be presented at a seminar. From experience, one should participate in all teaching to pass the exam. More detailed information on the different parts of the course is provided in conjunction with the start of the course.

The course contains the following major topics.

1) Planning and building legislation

2) Environmental Code and rules on the protection of cultural monuments

3) Project / Assignment

First and second torque areassessed through written tests and / or examinations. The third partis examined in a written submission, attendance at the elements that belong to the task and or al presentation and active participation in seminar.
