Intended learning outcomes

At the end of the course, the student should be able to:

- identify tones and syllables in clearly spoken Mandarin Chinese, and understand sentences and clause patterns in everyday use
- understand simple texts
- use the language in simple conversations
- give short presentations on a prepared topic
- translate sentences in everyday use as well as simple texts from Swedish to Chinese
- translate sentences in everyday use as well as simple texts from Chinese to Swedish.

Course contents

The course continues to build on the Advanced Beginners' Level I with continued study of the most important and commonly used clause patterns in Mandarin Chinese. In addition there are writing and translation exercises and an introduction to written and spoken Chinese for specific purposes. The course comprises appr. 360 characters.

56 lessons divided into 28 sessions x 2 lessons during the academic year (periods 1-4).

Examination

- TENA - Examination, 2.0 credits, grading scale: P, F
- TENB - Examination, 2.0 credits, grading scale: P, F

- TEND - Examination, 2.5 credits, grading scale: A, B, C, D, E, FX, F

Other requirements for final grade
