# Intended learning outcomes

The student should be familiar with practical and theoretical knowledge concerning:project design- work performance- personal development- leadership- motivationThe student should be able to carry out power games in organizations and specifically know:- How
to negotiate to win- How to handle group processes end personal empowerment- How
to present and argue for complex ideas based on rhetorical principles- How to promote
creativity and innovation- How to diagnose organisational cultures- How to measure work
performance- How to control the workforce

#### Course contents

We will study theories concerning leadership, organisation, group dynamics and project methodology

Each student will participate in 7 seminars where the student is trained to be a leader We will study theories concerning human relationships, negotiation and conflict resolution We will study theories about game theory and experiment with various strategies in how to gain power in a competitive environment

We will study the art of delegating responsibility and power without losing control During the whole course there is a focus on communication skills

The participants must be able to engage in exercises involving situations where they are criticised for their behavior by their fellow students. This implies that students who are uncertain whether they can benefit from such activities should not participate in the course. The course involves 7 training seminars where each student will get intense feedback concerning their leadership skills and communication skills.

It is not possible to participate in the course if the student does not have time to be present in most seminars

All lectures will be held in English

All course material will be in English with the exception of some references to Swedish material for Swedish students
